According to the United States Department of Health and Human Services, there are some simple steps that you can take to help promote a drug-free workplace environment.

Develop and distribute a written policy

Part of this packet includes a photocopy-ready information page that includes background information on the dangers of meth as well as a space for you to write in your company's own drug policies. For those employers who do not currently have a written policy on drugs in the workplace, the *Meth Destroys* campaign is also including a prepared statement on the importance of a drug-free workplace.

Provide your employees with access to assistance

In Tennessee, you can contact the Tennessee Association of Alcohol, Drug and Other Addiction Services' Redline number at (800) 889-9789. The Redline number offers referral services for any person who calls seeking assistance and resources on substance abuse and addiction. The number is listed on both your workplace poster, and the photocopy-ready information page.

Educate your employees on the dangers of drugs like meth

Included in this packet is a quantity of *Meth Destroys* education brochures that can be placed in common areas around the office. In addition, the workplace posters included in this shipment have background information on meth and its dangerous effects. Encourage all your employees to visit www.MethFreeTN.org to learn more about meth.

Supervisor training

It is important for all employees, including supervisors, to understand why meth is so dangerous and how your company can both deter meth use in the workplace and help individuals who are battling addiction. Make sure that your supervisors are aware of the physical indications of meth use and have the TAADAS Redline number handy to provide to employees.
